IIBA's terms and conditions for events are set out in full below. Please read carefully when you register for the 27th IIBA International Conference.

1. Registration

1.1 Registration

All participants of the 27th IIBA International Conference have to register by filling in the registration form.

Registration is **ONLY** confirmed after receiving full payment.

As of September 5, 2025, the registration will be closed for administrative purposes.

1.2 Discounts

If you are eligible for a discount, please ensure that you indicate your eligibility for the discount in your registration form.

Attention: Please note that reimbursement for registration fees paid without the applicable discount selected will not be accepted.

Discounts available:

 Host hotel discount: You can benefit of a discount for the 27th IIBA International Conference Pass when you book your room through the accommodation link provided on our website.

Discount for the 27^{th} IIBA International Conference Pass: USD 100

BIPOC discount: Up to 10 participants by region (region 1: North America, region 2: Europe, region 3: Latin America) can self-identify as BIPOC and access to the BIPOC fund. The principle of first come, first served is applied. Please note that the BIPOC discount cannot be combined with the conference scholarship.

Attention: Only available during the Early Bird registration period.

The 27th IIBA International Conference Pass is discounted by 50%.

1.3 Scholarship for IIBA Trainees

IIBA trainees (currently involved in a training group following the IIBA Curriculum) can apply for a conference scholarship.

Attention: The principle of first come, first served is applied

For more details about how to apply, please request details to the IIBA Back-Office.

Please note that the conference scholarship cannot be combined with any other discount options and is only available during the Early Bird registration period.

When registering, please ensure you have previously applied for the Scholarship for IIBA Trainees.

Kindly note that if the registration fee is paid without indicating your scholarship application, and the scholarship is later granted, we will be unable to reimburse the registration fee.

Discounted 27th IIBA International Conference Pass: Only USD 100 $\,$

1.4 Payment

After submitting the registration form, the IIBA reviews the information and send a payment request within 2-5 business days. Payment must be made in full in 3 working days after receiving the payment request. Failure to do so will result in the registration being voided.

The participant can select among 2 payment methods:

- Credit / Debit card payment in USD.
- Bank wire in EUR (only for participants registering from the European Union).

Attention: We do not accept cheque as payment. Any additional bank transfer costs will need to be paid by the participant.

Upon receipt of payment, the participant will receive a confirmation receipt confirming their registration. This confirmation must be presented during check-in at the 27th IIBA International Conference.

The date of payment is decisive for the registration fee. Even if the registration form is received before the early bird or regular deadline, it will not be considered as early or regular registration if the payment has not been received before the deadlines.

1.5 Cancellations

The refunds and options set out below are exclusive of any other compensation, including without being exhaustive, any cost or loss, incurred or suffered by the participant, in relation to the cancellation of the event (by the participant or the IIBA), such as travel and accommodation fees, which are entirely the participant's responsibility and therefore will not be reimbursed.

1.5.1 Cancellation by the participant

Date of cancellation before the event	Value of refund
Received by Apr 1, 2025	Registration fee minus a 30% processing fee.
Received by Jul 31, 2025	Registration fee minus a 70% processing fee.
Received after Aug 1, 2025	No refund.

The IIBA Back-Office will deal with refunds once the conference will be finished.



1.5.2 Cancellation by the IIBA

Cancellation by the IIBA, changes in the date and/or venue or modifying the format to a virtual alternative any time prior to the event:

Cancellation	Refund of the registration fees.	
Changes of date and/or venue	The amount paid for the registration fees of the modified event is carried forward to another IIBA event.	
Modification to a virtual alternative	Part of the amount paid for the registration fees will be used for the virtual alternative. The remaining amount will be refunded.	

In case the local authorities impose restrictions on the number of event attendees, and that new number is less than the number of registrations the IIBA received, priority for attendance will be given to those essential to run the event, i.e. those part of the event organisation, speakers and leadership. Among the rest of the registered delegates a raffle will decide who will be able to attend in order to give everyone an equal chance.

2. Substitution

If a participant is unable to attend, they may send a substitute participant at no extra cost, provided that the substitute's registration category is the same. Please notify the IIBA in writing (info@bioenergeticanalysis.com) by September 5, 2025. Any notifications received after this date cannot be processed.

3. Attending the event

3.1 Travel

The IIBA accepts no liability if a participant is unable to attend the 27th IIBA International Conference due to adverse weather conditions or any travel disruption.

Participants should ensure they comply with all the requirements of the country where the 27th IIBA International Conference is taking place before registering (for instance entry and stay criteria, visa, restrictions, security, safety).

The IIBA welcomes participants from overseas, however, everybody should ensure that they have a valid visa and can comply with all immigration requirements before registering.

If you do not have a visa before registering and are unable to obtain one in time for the 27th IIBA International Conference, the cancellation fees applied shall be those set out above (see 1.5.1 Cancellation by the participant).

The IIBA reserves the right to crop, splice, treat and edit any imagery or photographs taken at this virtual conference.


The participant waives the right to inspect or approve the finished product, including written or electronic copy.
